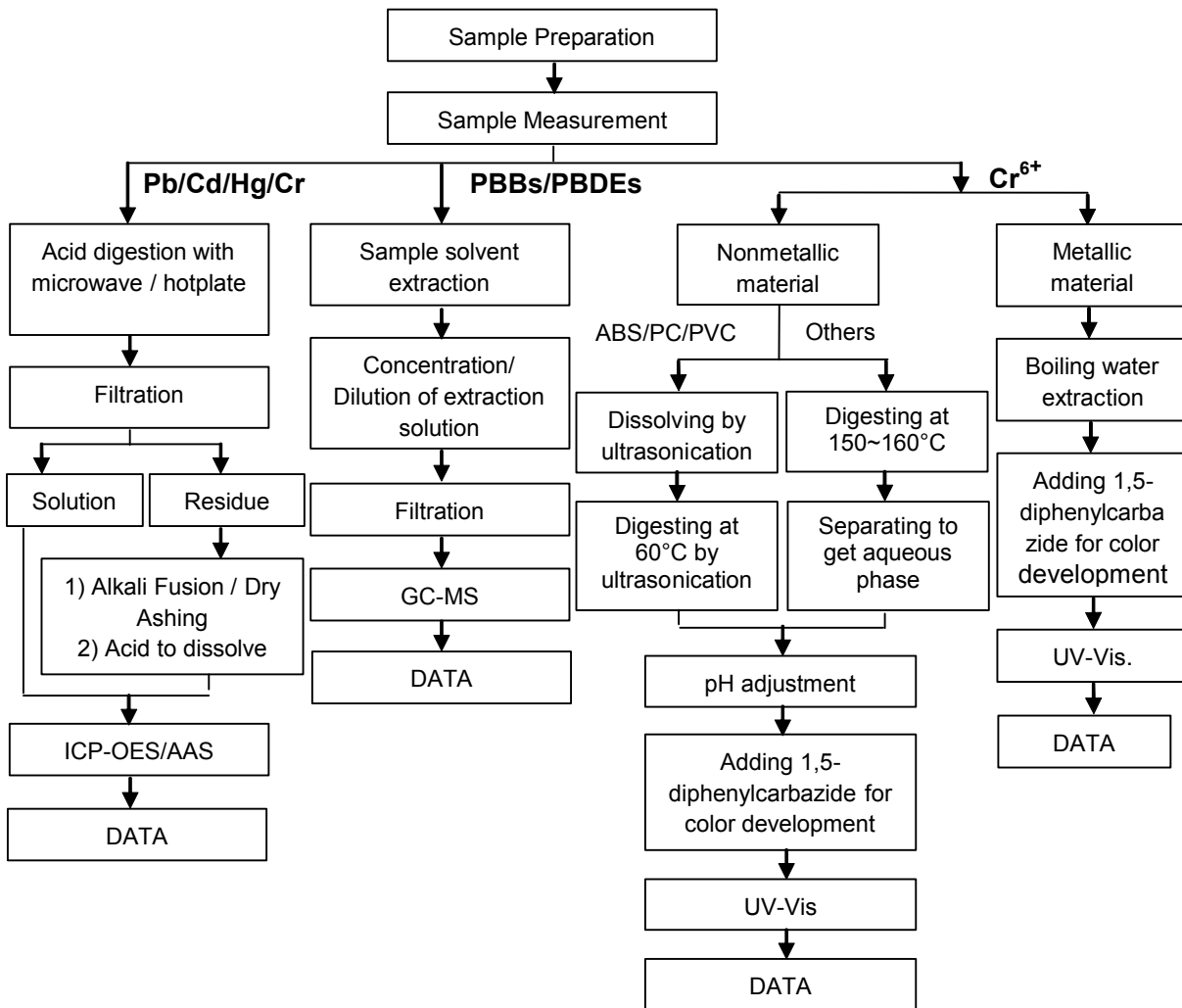

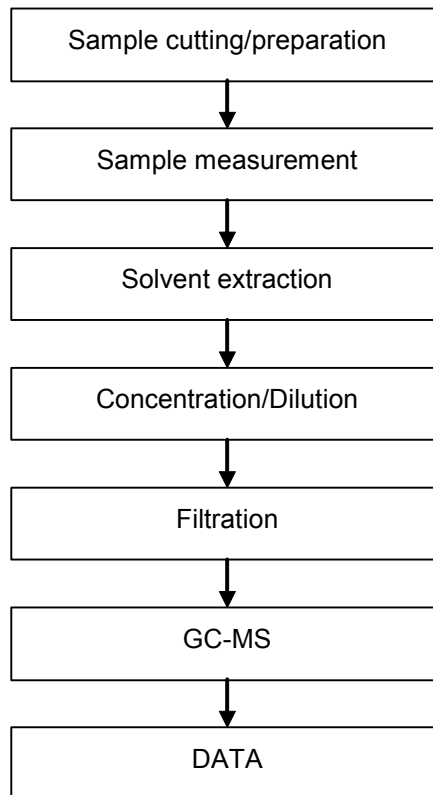

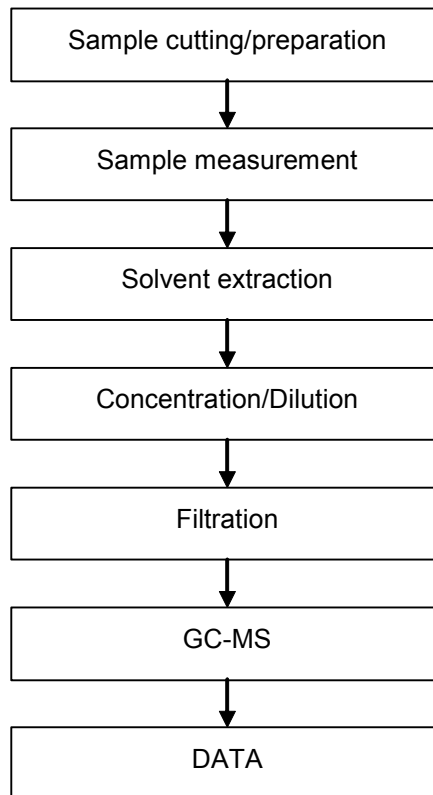

PAHs Testing Flow Chart

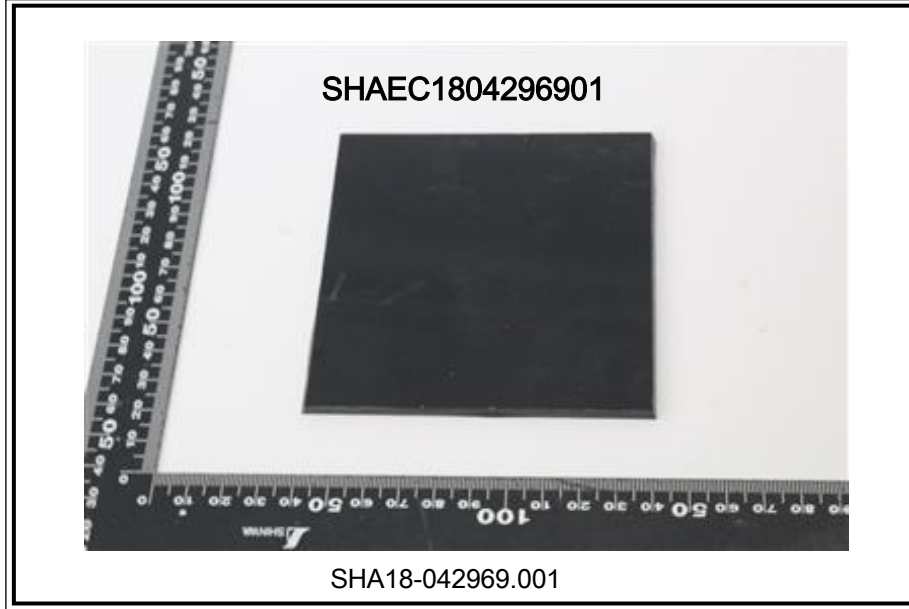
